### Timetable, background information and arrangements for admission to Ranelagh School: September 2019

The admission arrangements for admission to Ranelagh School from September 2019 were subject to consultation in 2015 in accordance with the School Admission Code 2014.

#### Timetable

Publication of Ranelagh School admission arrangements for September 2019 on the Ranelagh School website: 28<sup>th</sup> February 2018.

Publication by Bracknell Forest Council of a Composite Prospectus for entry to Year 7 for Ranelagh and other Bracknell Forest Secondary Schools: **12<sup>th</sup> September 2018** (on the Bracknell Forest Council website and also available in hard copy; many local primary schools may distribute copies).

Information evenings for prospective Year 7 parents: **20<sup>th</sup> September and 24<sup>th</sup> September 2018**. The Ranelagh Prospectus, including admission arrangements, will be available at these and on the school website.

National closing date for secondary school applications: **31<sup>st</sup> October 2018**.

National offer day for secondary school places: **1<sup>st</sup> March 2019 or next working day**.

**Appeals should be made by 30<sup>th</sup> April 2019 - to guarantee being considered in the main appeal hearings which are usually held in the first half of May.**

#### In-Year Applications

Application may be made at any time after the start of the year for admission to Ranelagh.

Ranelagh complies with Bracknell Forest's timeline for admissions and therefore an application for the next academic year can be made no earlier than the date set out in Bracknell Forest's Guide to In-Year Applications.

#### Sixth Form Applications

The closing date for sixth form applications is **1<sup>st</sup> December 2018**

#### **Published Admission Number (PAN)**

The Governors have determined that the Year 7 PAN for September 2019 shall be 165 students.

The Governors have determined that the Year 12 PAN for external applicants in September 2019 shall be 15 students.

## Analysis of admissions 2018

Ranelagh is a very popular school and has been oversubscribed for a number of years.

For entry in September 2018 for Year 7 initially 165 places were available. The initial allocation of places was as follows: 12 places to Looked After Children [LAC] and 4 children with Educational Health Care Plan [SEN], were awarded a statutory place leaving a further 149 places to be allocated by the Governing Body.

In May, the Governing Body at Ranelagh agreed to admit 9 students above PAN for Year 7 entry in September 2018.

## Background information

### Years 7 -11

Please note the following definition of categories for the analysis of admissions from 2017

**LAC** 'Looked After Children'

**SC** Children of paid staff (as defined below), in either or both of the following circumstances:

- a) where the member of staff has been employed at the school for two or more years, and/or
- b) the member of staff is recruited to fill a vacant post for which there is a demonstrable skill shortage. at the time at which the application for admission to the school is made

**MPP** Children (or parents) who have exceptional medical, physical or psychological needs that make it essential for the child to attend Ranelagh School rather than any other. These needs must be fully supported by written evidence from the appropriate professional person involved with the family.

**A** Children of applicants who have attended public worship in an Anglican Church or Church of another Christian denomination on average at least once a month in the twelve months preceding the date of this application and who will have a sibling attending the school at the time at which the application for admission to the school is made.

**B** Children of applicants who are resident in the deaneries of Bracknell or Sonning, who are on the Electoral Roll of an Anglican Church and who have attended public worship in an Anglican Church on average at least once a month in the twelve months preceding the date of this application.

**C** Children of applicants who are resident in the deaneries of Bracknell or Sonning, who are not on the Electoral Roll of an Anglican Church, but who have attended public worship in an Anglican Church on average at least once a month in the twelve months preceding the date of this application.

**D** Children of applicants who are resident in the deaneries of Bracknell or Sonning, who have attended public worship in a church of another Christian denomination on average at least once a month in the twelve months preceding the date of this application.

**E** Children of all other applicants.
